Many Clients will only allow inflatable equipment on their sites if it is PIPA compliant. The problem is that all inflatables are not currently covered by the scope of the PIPA scheme. Those items not covered by the PIPA scheme include, multi ride beds, surf beds, tumble tracks, bungee runs, pole joust, gladiator joust, inflatable games, inflatable parks and all water-based inflatables. Non-Ride On games\*/Playzones **ARE** included within the PIPA scheme.

\*Non-ride on games - Inflatable games which a person does not have to get onto, into or inside the device to participate. The user can come into contact and interact briefly. They are of a constant air design, and not sealed air units. Examples Include: - Archery & Shooting Ranges - Basketball hoops - Lassos - Bowling Alleys - Dartboards
